52.212-2 EVALUATION--COMMERCIAL ITEMS (JAN 1999)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. This solicitation may result in multiple awards. The Government will use the lowest price technically acceptable source selection process. The following standards shall be used to evaluate offers:

(i) Offeror must meet or exceed the following minimum requirements in order to receive further consideration:

- a. Physical Therapist certification for the candidate(s) being proposed to perform the required services.
- b. The candidates(s) being proposed to perform the required services must have a minimum of six (6) months pediatric experience.

(ii) The technical proposal must meet the requirements set forth in the Performance Work Statement (PWS).

(iii) Past performance: In accordance with clause 52.212-1 Addendum, paragraph (b) (10).

(iv) Price.

The proposal must meet or exceed the acceptability standards above, and past performance must be rated satisfactory or above to be considered for award. Award will be made to the lowest-priced offer with acceptable technical proposal and past performance rating.

(b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. “Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person conducting the business can demonstrate--

1.1.4. Contractor Employee Removal

1.1.4.1. At the direction of the Contracting Officer, the contractor is required to immediately remove any person from work under this contract should it be determined by Government that such a person has violated or is in

PERFORMANCE WORK STATEMENT

1.0 PURPOSE: The Department of Defense Education Activity (DoDEA) requires Physical Therapist (PT) services for the Fort Campbell Schools for the period of performance 24 August 2009 through 31 Oct 2009, in support of the Special Education Program for the DoD Domestic Dependent Elementary and Secondary Schools (DDESS) located at Fort Campbell Schools, Kentucky.

2.0 BACKGROUND: PT services are one of the services mandated for provision of special education services to DoDEA students with disabilities under the DoD Instruction 1342.12. "Provision of Early Intervention and Special Education Services to Eligible DoD Dependents," April 11, 2005.

The Case Study Committee (CSC) is responsible for determining if a student requires PT services in accordance with the Individualized Education (IEP) goals. An IEP is the document written by the CSC that establishes the

goals and services that must be provided to a student with a disability in order to provide a Free Appropriate Public Education (FAPE). The required services shall be provided with linkage to the educational needs of the student rather than to the medical needs of the student.

3.0 TECHNICAL QUALIFICATIONS: The Contractor shall:

- 3.1. Be a Certified/Credentialed Physical Therapist.
- 3.2. Have pediatric and adolescent experience.
- 3.3. Have experience working in educational settings.
- 3.4. Have experience with the implementation of IEPs.
- 3.5. Be proficient in English.
- 3.6. Possess basic computer skills.
- 3.7. Be able to work the portion of the scheduled school year calendar covered by the performance period (see paragraph 4.0).
- 3.8. Be able to work in the school and on-post residence setting.

4.0 REQUIREMENT: The contractor shall provide Physical Therapist Services five days per week IAW school calendar (see Technical Exhibit 1) at Fort Campbell Schools as directed by the Government.

4.1. General.

4.1.1. Generally, services shall be provided during the regular school year. The regular school year hours are between 0800 and 1530 excluding lunch, on days when classes are in session. (TE-1). The Fort Campbell Schools Special Education Coordinator may schedule additional hours before or after the regular school day, on teacher work days, professional development days or early dismissal up to 40 hours per week.

4.1.2. Time required for Government provided training (Reference 6.1 and 6.2) will be paid at the same rate as services.

4.1.3. Services may require travel to a residence(s) on Fort Campbell to provide service to homebound student(s) at no additional charge.

4.1.4. Time and expenses associated with compliance with Fort Campbell's vehicle Access Control Procedures are the responsibility of the contractor.

4.2. Task.

4.2.1. Provide direct Physical Therapy (PT) services in accordance with IEP goals for students in grades Pre-School Child Development (PSCD) through 12.

4.2.2. Provide consultative PT services to staff, parents, and students in accordance with IEP goals.

4.2.3. Attend meetings and assist in the development of IEPs for students found eligible for PT services.

4.2.4. Perform observations, screenings, and evaluations at school and on post resident locations. (see Technical Exhibit 2).

4.2.5. Write evaluation reports to include diagnostic findings and educational implications.
